WITH MORE THAN A THOUSAND SUPPORTERS, HSF IS THE RECOGNIZED LEADER OF THE LOCAL PRESERVATION MOVEMENT. HSF ADVOCATES, EDUCATES AND GETS DIRECTLY INVOLVED IN PRESERVING AND PROTECTING SAVANNAH'S HERITAGE. THROUGH THE USE OF A REVOLVING FUND, WHICH ACQUIRES AND RESTORES ENDANGERED HISTORIC BUILDINGS, A VARIETY OF EDUCATIONAL PROGRAMS TO TRAIN YOUTH AND ADULTS, AND THE DAVENPORT HOUSE MUSEUM, WHICH SERVES AS AN EXAMPLE OF GOOD STEWARDSHIP, HSF TOUCHES TENS OF THOUSANDS OF PEOPLE EACH YEAR. 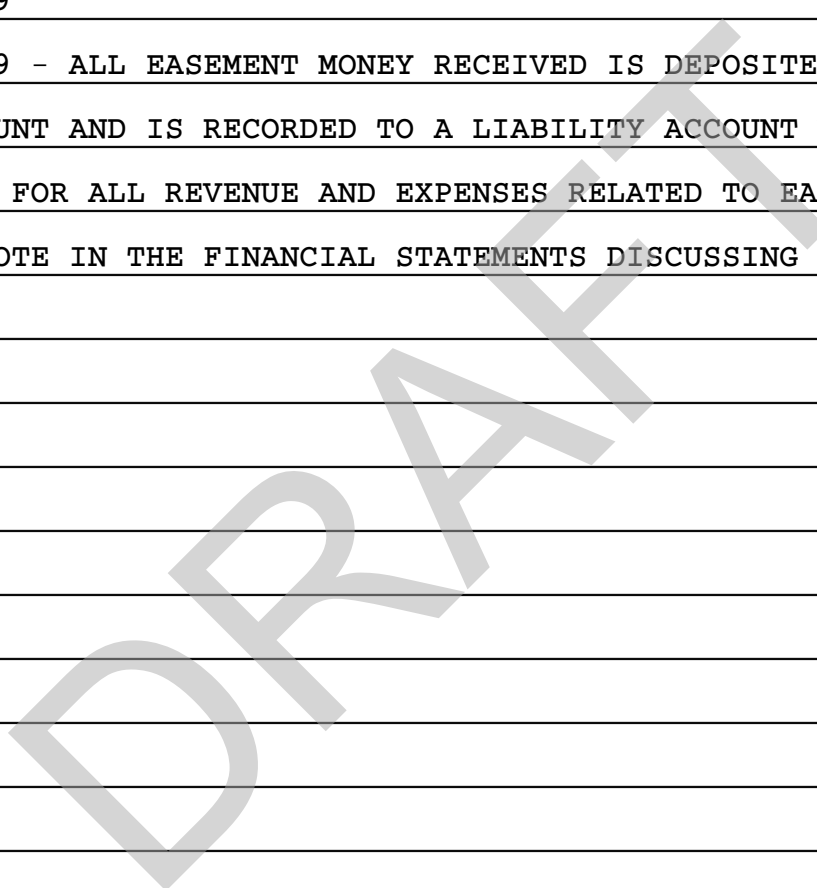

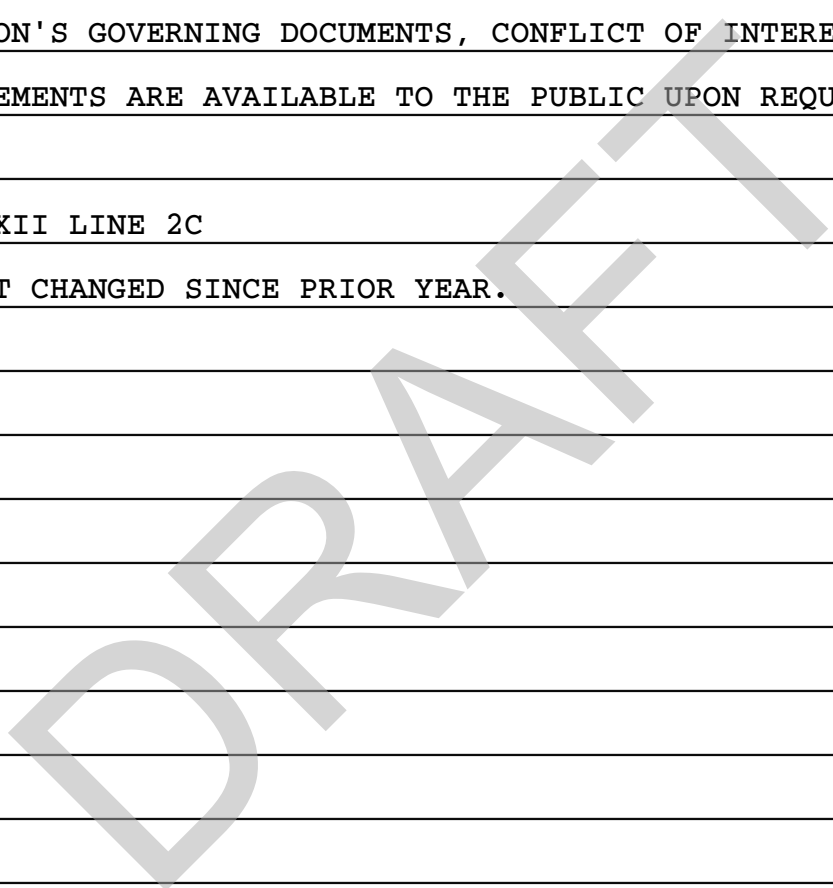
