TOUR AND MUSEUM OPERATIONS - THE ISAIAH DAVENPORT HOUSE (C. 1820) WAS THREATENED WITH DEMOLITION IN 1955 WHEN THE FOUNDERS OF HSF ("SEVEN LADIES") INTERVENED AND PURCHASED THE BUILDING. NOT ONLY WAS THE BUILDING SAVED AND RESTORED INTO A HOUSE MUSEUM THAT HOSTS 40,000 VISITORS A YEAR, BUT HSF WAS FORMALLY ORGANIZED TO BECOME THE VOICE FOR PRESERVATION IN SAVANNAH AND CHATHAM COUNTY. THE DAVENPORT HOUSE FOCUSES ITS INTERPRETATION ON ARCHITECTURE, CRAFTSMANSHIP AND LIFE IN SAVANNAH DURING THE 1820S. IN ADDITION, THEY OFFER A VARIETY OF DRAMATIC PROGRAMMING WHICH HIGHLIGHTS SUBJECTS RANGING FROM URBAN SLAVERY TO YELLOW FEVER.

THE SAVANNAH PRESERVATION FESTIVAL AND HSF'S GALA AFFORD HUNDREDS OF PEOPLE THE OPPORTUNITY TO ENJOY SOCIAL INTERACTION IN UNIQUE HISTORIC SETTINGS. AND, FROM AN ADVOCACY STANDPOINT, HSF IS ACTIVELY INVOLVED IN THE PLANNING PROCESS IN SAVANNAH AND CHATHAM COUNTY.
